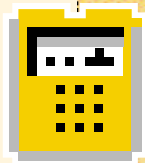

Users need no special software to view, search or print! Mac-using attorneys can even download the free E-Transcript Mac Viewer from [www.RealLegal.com](http://www.RealLegal.com) for complete E-Transcript functionality. If your firm has a firewall and cannot accept EXE files, just ask your court reporter to send you PTX files. The PTX format is smaller, thereby taking less time to transmit via the Internet and less storage space, and since it is not an executable file, it will pass through e-mail systems and firewalls. All you need to do to open this PTX file from your court reporter is download the free E-Transcript PTX Viewer from [www.RealLegal.com](http://www.RealLegal.com).

E-Transcript's print utility is built right into the Viewer. You don't need to use another program to print single transcripts or do condensed printing. Some of the powerful print features let users:

- Print single transcripts, word indices, or condensed prints from one to 16 pages of professional quality, clean, readable transcript per sheet.
